Introduction

Membership in the IACAPAP comprises four categories: **Full Member organisations** (national organisations), **Affiliate Member organisations** (other organisations), and **Individual Members**.

The IACAPAP operating and membership year runs from January 1st to December 31st. To ensure that you are eligible for all membership benefits for the current year, membership fees should be paid before Feb 15th.

Membership Categories

Full Membership is opened to *bona fide* national organisations whose members are composed of child and adolescent psychiatrists or child and adolescent psychiatrists and allied mental health professionals.

Affiliate Membership is opened to other international, national or local organisations consisting of child and adolescent psychiatrists and/or allied professionals in child and adolescent mental health with or without allied mental health professionals.

Individual Membership of the Association is opened open to a child and adolescent psychiatrists, other mental health professionals or professionals in training who devote themselves to the study, treatment, care and prevention of mental and emotional disorders and disabilities in children and adolescents, and their families.

1. Application Submission

- Membership applications are submitted online
- New applicants shall provide the following documents

- For application approved on or before November 30th of the year, the whole year's annual fee will be charged.
- The application submitted after November 30th, the Membership Committee will put your application on hold now and review it in a new calendar year starting January 1st.

2. Application review and approval of an applicant

- Full and Affiliate membership application needs to be approved by the Executive Committee.
- Individual Member application needs to be approved by the Membership Committee chaired by the Secretary-General.

Membership Renewal

1. Membership tracking

- Standard membership is January 1st through December 31st.
- Members whose dues are in arrears more than **45 days** are not eligible for any benefits of membership.

2. Dues renewal

- On January 1st the Administrator mails dues renewal letters to all members.
- Schedule of mailing of invoices
 - o Month 1 (January) > Email invoice.
 - o After 30 days > 1st reminder. The Administrator mails a notice to members who have not renewed their annual membership. This notice will remind members they must renew their membership to serve or participate in any IACAPAP activities.
 - o After 45 days > The membership status will be converted from unpaid to lapsed automatically should there is no payment from the members.
 - o After 60 days > Final reminder. The Administrator mails a notice to members who have not renewed their annual membership. This notice will remind members they must renew their membership to serve or participate in any IACAPAP activities.
- Members who have not renewed have the option to renew their membership by paying fees for the current year for two consecutive years without any formal application and approval. After that period, a new application and approval are necessary.

Membership Waiver Request (Individual Member)

IACAPAP offers a membership fee waiver to IACAPAP Individual Members from developing countries (as per the [World Bank Income Classification](#) of Low and Lower-Middle Income Countries). All applications should be submitted online. To apply online ([click here](#)) with additional supporting documentation:

1. Letter of appeal (300 words max) indicating name, affiliation, address and contact details.
2. Curriculum vitae, maximum 03 pages, including career history, awards, education, publications, research activities and further relevant information.

The applicant should be a current active paid IACAPAP Individual Member in the past records.

After completing the application online, you will receive an acknowledgement email. Only completed applications will be reviewed by the Membership Committee. All information received will be considered confidential. You will receive a notification from the IACAPAP Administrator to let you know if your request is approved within 14 business days.

Membership Withdrawal Request (Full Member and Affiliate Member)

The member must submit an official letter indicating the following:

- The withdrawal request
- The reason for the withdrawal

An acknowledgement email will be sent upon receiving the withdrawal request letter. All information received will be considered confidential. You will receive a notification from the IACAPAP Administrator to let you know the status within 30 business days.

Membership Dues
